Non-Renounceable Pro-Rata Entitlement Offer - Allocation of Shortfall

Magnum Mining and Exploration Limited ('Magnum' or 'the Company') refers to its announcement on 12 August 2019 in regard to the Non-renounceable Pro-rata Entitlement Offer ('Entitlement Offer') of up to 101,526,273 New Options to raise up to approximately \$1,015,263 pursuant to the Entitlement Offer Prospectus dated 12 August 2019.

The Company closed the Entitlement Offer on 23 September 2019 receiving eligible applications for 41,736,965 New Options and 20,913,917 Shortfall Options (applied for by eligible shareholders in excess of their entitlement), each exercisable at \$0.05 on or before 30 September 2022, raising total funds of \$626,508.82 before costs.

As a result, there was a shortfall of 38,875,391 Shortfall Options or \$388,753.91 ('Shortfall'). The Company advises that under the terms of the Entitlement Offer, the Shortfall has today been placed to professional and sophisticated investors.
