VIRTUAL MEETING GUIDE AND NOTICE OF MEETING - UPDATE

Magnum Mining Exploration Limited (ASX:MGU) (**Company**) wishes to provide an update in relation to its previous letter to shareholders (announced 9 July 2021) regarding the extraordinary general meeting of Shareholders at 10:00 am (AEST) on 20 July 2021 (**Meeting**).

In accordance with the health advice of the Victorian Government and following yesterday's announcement confirming Melbourne has entered lockdown¹, the Company wishes to advise Shareholders that they will no longer be able to physically attend the Meeting. Shareholders may participate in the Meeting via zoom, with online voting provided by the Company's Share Register, Computershare. Further, all resolutions will be decided on a poll. The poll will be conducted based on votes submitted by proxy and by Shareholders voting online vote at the Meeting in accordance with the instructions below.

Directors encourage all shareholders to lodge a directed proxy form prior to the Meeting, under which the Chair is appointed as your proxy to ensure the proxy will be in attendance at the Meeting. If a person other than the Chair is appointed as proxy, the proxy will revert to the Chair in the absence of the appointed proxy holder's attendance at the Meeting.

How Shareholders can participate

Shareholders will be able to participate in the Meeting by:

(a) voting their Shares prior to the Meeting by lodging the proxy form attached (example) to the Notice of Meeting by no later than 10:00 am (AEST) on 18 July 2021;

(b) lodging questions in advance of the Meeting by emailing the questions to the Company Secretary at <u>john@mmel.com.au</u>; and/or

(c) attending the Meeting via zoom (which will include listening and asking questions, and voting in the manner set out below during the Meeting via the Lumi Platform).
